WHY WE PROCESS YOUR DATA

We seek your consent to use your name and contact details for the following reasons. Consent can be withdrawn at any time by contacting us.

- **TO KEEP IN TOUCH**
Informing you of news, events, activities and changes to the regular rhythm at Reset Church.
- **TO PROVIDE PASTORAL SUPPORT**
This includes pastoral notes, the making of pastoral care phone calls, collating Christian journey data (baptism dates etc.)
- **TO MANAGE CHURCH TEAMS**
If you commit to helping on one of our teams, we will need to process your contact details in order to share relevant information with you and other team members.
- **TO ENABLE US TO PROVIDE A VOLUNTARY SERVICE FOR THE BENEFIT OF THE PUBLIC**
This is in regard to church activities, events, ministries, fundraising, promotion and projects.
- **TO MAINTAIN OUR OWN ACCOUNTS AND RECORDS**
Including the processing of gift aid applications, held for up to 6 years after the calendar year to which they relate.

HOW WILL YOU STORE MY DATA?

We keep data in accordance with the guidance set out by Elim Foursquare Gospel Alliance. (Further information of this can be found on the Elim website). Practically and securely, this will be on our electronic church database, google drive, mail chimp, laptops (both staff and volunteers own laptops), mobile phones (staff and volunteer's personal phones) and in our paper filing system in our church office.

Only when you give us consent or when we are required to by law.
